 - b. In the case of Income & Expenditure Account for the Year ended on that date

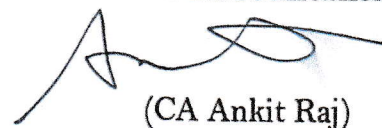

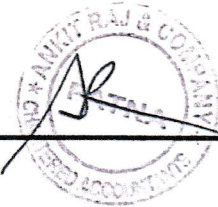
